## Breeding Right Agreement

Mare owner hereby confirms a reservation to the stallion **Otteridge Foxtrot** for the 2007 Breeding Season. This breeding right is sold with a **Two Year term on a Live Foal Guarantee**. Mare is contracted specifically by name. The contract may not be transferred to another mare without the prior written consent of Scott Canard. If the semen is used on a mare not named in this contract without Scott Canard's written consent, this contract and all of its guarantees becomes null and void.

## Fees and Terms

- \* The non refundable booking fee of \$50.00 USD is due at the signing of this contract.
- \* The non refundable stud fee of \$500.00 USD must be paid in its entirety before the first shipment of semen. All fees are made payable to **Scott Canard**.
- \* The breeding season begins February 12, 2007 and ends on July 30, 2007.
- \* Scott Canard requires 24 hours notice prior to when semen collection is needed.
- \* Otteridge Foxtrot will stand at **Equine Reproduction Concepts, Inc. (hereinafter "ERC")** for the 2007 breeding season. ERC is located at:

- \* All fees related to the collection and shipment or insemination of semen and mare care are payable to ERC. Fees are subject to change, Mare Owner must contact ERC for pricing and breeding procedures.
- \* Scott Canard **AND** ERC requires 24 hours notice prior to when semen collection is needed. An initial call to ERC and Scott Canard should be made on the first day of heat to confirm that breeding will occur during the cycle. All semen orders should be received by 12:00 pm EST, on the day before the anticipated collection/shipment date.
- \* A credit card or deposit is required to secure the Equitainer prior to shipment. In case of loss or damage of the Equitainer, the credit card number will be charged in the amount of \$325.00 for the Equitainer. If the Equitainer is not returned within 5 days of the receiving the shipment a \$10.00 per day late fee will be charged. However, if no loss or damage to the Equitainer occurs, and was returned within the 5 days, no charges will be made to mare owner's credit card, or deposit will be returned.
- \* All semen transportation costs will be the sole responsibility of the Mare Owner. All shipping and collection costs will be charged to Mare Owner's Credit Card or Mare owner agrees to pay by check before each semen order is sent.
- \* Upon written request to Scott Canard the breeding agreement may be extended beyond the contracted two years.

## Conditions

- \* The Mare Owner agrees to observe protocol for shipment of fresh cooled semen as determined by Scott Canard.
- \* All semen must be administered by a licensed veterinarian, and semen must be administered on the day of delivery or Scott Canard, Stallion Owner, shall be considered to have fulfilled all contractual obligations. If more than 2 shipments of semen are required during the breeding season a veterinary certificate explaining suspected reasons for the infertility of these previous two breedings will be required along with an additional negative uterine culture.

\*Scott Canard by and through ERC makes every effort to collect and ship the highest quality semen. However, we can make no guarantee or warranties on the condition of the semen due to the nature of shipped semen.

\* Mare owner by his/her signature acknowledges that under no circumstances will fees be refunded.

\* The Mare Owner assumes all responsibility for the condition of the mare and shall bear all risk of loss or to the mare, whether by death, disease, injury, infection, or otherwise, and agrees to hold Stallion Owner, Scott Canard, their employees agents, successors, and assigns, harmless from any and all damages associated therewith.

\* The Mare Owner must ensure the health, condition, and breeding soundness of the Mare prior to insemination. The Mare Owner must have the mare checked for pregnancy by a licensed veterinarian before 18 days, and again for viable pregnancy at 30 days, and 60 days after the last insemination, and must inform Scott Canard of the mare's pregnancy status.

\* If the mare dies prior to insemination, or if after examination by two licensed Veterinarians is found to be unfit to breed, another mare may be substituted with the written consent of Scott Canard, with the same terms and conditions applying. If the mare is examined by a licensed veterinarian and found to be barren 60 days from the last date of service, return privileges are granted. Written notice of loss of any pregnancy after 60 day check is required with in 10 days in the form of a Veterinarians Certificate in order to receive return privileges.

\* In the event that the mare is sold after breeding, no return privileges shall be made to the purchasing party.

\* This contract carries a Two Year Live Foal Guarantee. If the mare herein named, or the mare substituted, fails to produce a foal that can stand and nurse within 24 hours of birth, Stallion Owner will, after the payment of the Booking Fee, rebreed the Mare in the following season, provided Scott Canard, is presented with a Veterinarian's Certificate outlining the details of the failed Pregnancy or the foal's death within 10 days of the its occurrence. Failure to Provide the Veterinarian Certificate within 10 days will nullify the guarantee.

\* Should the Mare Owner use the return privileges, these same terms and conditions apply.

\* If the Mare Owner at any time fails to satisfy one or more of the conditions set forth above, Stallion Owner shall thereupon be deemed to have satisfied all duties herein and will not be obligated to deliver additional semen to the Mare Owner.

\* If after two breeding seasons, the mare still fails to conceive, or deliver a live foal this contract will be considered Fulfilled in its entirety.

\* In the event that the stallion dies, is sold, or becomes in any way unfit for service Mare Owner and Stallion Owner will be released from this contract.

Read this contract carefully. Sign and return a copy with the booking fee to Scott Canard. Upon completion of signing, this contract becomes a full binding agreement between both parties, subject to all stipulated terms and conditions and sets forth the entire agreement of the parties. This contract shall not be assigned or transferred by the Mare Owner. This contract shall be interpreted in accordance with the laws of the State of Virginia.
